PFAS & Biosolids Management

- PFAS Liability: Right now, PFAS regulations can leave communities
 responsible for contamination caused by major corporations. Supporting
 explicit exemption from PFAS and PFOA cleanup liability with the
 passage of H.R. 1267—Water Systems PFAS Liability Protection Act— will
 correct this problem.
- PFAS Destruction Technology: Support additional research to destroy and ultimately remove PFAS and PFOA from our environment
- Encourage States to have **Biosolids Management Plans** that appropriately and effectively consider long-term management options.

General Regulations

- Keep Tax Exempt Status on Municipal Bonds: Municipalities across the
 country assume responsibility and financial risk for significant infrastructure
 projects that are needed to support economic development. Tax exempt bonds
 are a critical tool for these projects, and we ask that tax-exempt status on
 municipal bonds be retained.
- Utilize Cost-Benefit Analyses for future federal and state regulatory
 mandates. Regulatory requirements need to be backed by sound scientific
 evidence because these requirements strain already-limited resources for our
 communities. Aging infrastructure is already a significant strain on Maine, and
 additional regulation without balanced scientific evidence does not serve our
 residents.
- Keep Worker Protections

 —Keep the Occupational Safety and Health
 Administration (OSHA) which is absolutely essential to protect our water
 workers.
- Federal Partnership and Support to Recruit the Next Generation of our Water Workforce—Promote the Water Workforce
